Introduction

The learning event is organised within the framework of the H2020 project [RoundBaltic](#) and its overarching objective of supporting the implementation of the Smart Finance for Smart Buildings initiative in the Baltic Sea Region, notably the project's direct target countries Poland, Latvia and Denmark.

Scope

The general scope of learning events under RoundBaltic is to address key aspects that can help accelerating energy efficiency investments in Poland, Latvia and Denmark as well as across the entire Baltic Sea Region (BSR) covering public and private buildings as well as the SME sector. The learning events will explore the specific challenges and solutions of these target countries and the prospects of replication in the BSR and EU wide.

The scope of the sixth and final learning event is to display achievements and experience gained under RoundBaltic, incl. sharing the good practice and experience gained under the project intervention and how to ensure sustainability of future actions.
